बढ़ते प्रदूषण पर अंकुश लगाने के लिए ग्रेप-3 लागू होने के बाद नगर निगम ने संसाधन बढ़ा दिए हैं। इसी कड़ी में मंगलवार को नगर आयुक्त एक ओर रोड स्वीपिंग मशीन का उद्घाटन किया। जिससे मशीन से धूल को उठाया जाएगा। नगर आयुक्त ने बताया कि नगर निगम सीमाअंतर्गत 10 रोड स्वीपिंग मशीन सड़क से धूल उठाने का कार्य बेहतर कर रही हैं। ग्रेप-3 लागू होने के बाद ट्रिपल पी मॉडल पर एक ओर रोड स्वीपिंग मशीन द्वारा धूल उठाने का कार्य प्रारंभ कराया गया है। इस मशीन से शास्त्री नगर कवि नगर जोन में धूल उठाने का कार्य बेहतर किया जा रहा है। हरी झंडी से पूर्व मशीन का डेमो लिया गया।नगर स्वास्थ्य अधिकारी डॉ मिथिलेश ने बताया कि बढ़ती वायु प्रदूषण को नियंत्रित करने हेतु लगातार प्रयास किया जा रहा है जिस के क्रम में ही टीपीएस कंपनी से संपर्क साधते हुए 1 माह के लिए ट्रिपल पी मॉडल पर रोड स्वीपिंग मशीन को सड़क पर कार्य करने हेतु उतारा गया है।ताकि रोड से डस्ट खत्म किया जा सके और प्रदूषण नियंत्रण में कार्यवाही की जा सके।

शिवाजी नगर थाना क्षेत्र के राजनगर में मंगलवार शाम ज्वेलरी खरीदने के बहाने आए बदमाशों ने एक ज्वेलर्स पर अंधाधुंध फायरिंग कर दी। इस घटना में दो गोलियां ज्वेलर के पेट में लगी हैं जिसे घायल अवस्था में मेदांता अस्पताल में भर्ती कराया गया है। वारदात को अंजाम देने के बाद बदमाश अलग-अलग गलियों में फरार हो गए। सूचना मिलते ही शिवाजी नगर थाना पुलिस सहित क्राइम टीम व आला अधिकारी मौके पर पहुंचे जिन्होंने आसपास लगे सीसीटीवी कैमरे की फुटेज कब्जे में लेकर जांच शुरू कर दी है। दरअसल, राज नगर के रहने वाले त्रिलोक सोनी की ओम नगर क्षेत्र में

शिव ज्वेलर्स के नाम पर ज्वेलरी शॉप है। मंगलवार दोपहर को वह अपनी दुकान में बैठे थे कि तीन युवक आए जिन्होंने घर में शायी होने की बात कहते हुए ज्वेलरी दिखाने को कहा। बताया जा रहा है कि जैसे ही त्रिलोक सोनी उन्हें ज्वेलरी दिखाने लगे तो उनमें से एक बदमाश उठा जिसने त्रिलोक सोनी पर ताबड़तोड़ फायरिंग कर दी। वारदात के बाद आरोपी मौके से फरार हो गए। गोली चलने की आवाज सुनकर जब आसपास के दुकानदार बाहर आए तो देखा कि एक बदमाश ज्वेलर्स को गोली मार रहा है और ज्वेलर्स मदद के लिए लोगों को पुकार रहा है। वारदात को अंजाम देने के बाद आरोपी अलग-अलग गलियों में फरार हो गए। सूचना मिलते ही पुलिस बल मौके पर पहुंच गया और मामले की जांच शुरू कर दी। पुलिस ने दुकान पर लगे सीसीटीवी कैमरे समेत आसपास की दुकानों में लगे सीसीटीवी कैमरे की फुटेज कंगाली शुरू कर दी है और डीवीआर को अपने कब्जे में लेकर जांच शुरू कर दी है। फिलहाल पुलिस आरोपियों की तलाश में जगह-जगह छापेमारी कर रही है।
