Members will have an opportunity to cast their vote(s) remotely on the business as set forth in the Notice of the AGM through remote e-voting. The detailed procedure of remote e-Voting for members holding shares in dematerialised mode, physical mode and members who have not registered their email addresses is provided in the Notice of the 34th AGM. The remote e-Voting period commences on **9.00 a.m. (IST) on Saturday, 05th September, 2026** and end at **5.00 p.m. (IST) on Monday, 07th September, 2026**.
During this period, members holding shares either in physical or dematerialized form, as on cutoff date, i.e. as on **Tuesday, 01st September, 2026** may cast their votes electronically. The e-Voting module will be disabled by NSDL for voting thereafter. A member will not be allowed to vote again on any resolution on which vote has already been cast.

- Dividend and Record Date and Mandate for receiving dividend:**
Final Dividend shall be paid to the equity shareholders whose name appear on the Register of Members of the Company or in the records of Depositories as beneficial owners of the shares on the **record date being Tuesday, 01st September, 2026**.
Further please note that pursuant to the amendment to Regulation 12 of the SEBI Listing Regulations effective from **18th November 2025**, the Company would be unable to pay dividends through physical instruments to shareholders whose Bank account details are not updated. Such members are requested to register their Bank account details with the DP in case of shares held in demat form, or with the RTA in case of shares held in physical form by submitting Forms ISR 1, ISR 2 and SH 13 along with requisite documents. SEBI vide its Master Circular No. HO/38/13/4/2026-MRSD-POD/44298/2026 dated 6th February 2026, has mandated that, with effect from 1st April 2024, dividend to security holders who are holding securities in physical form shall be paid only through electronic mode. - Communication on Tax deduction on Final Dividend for FY 2025-26**
As you are aware, the Company is required to withhold taxes at the prescribed rates on the dividend paid to its shareholders in accordance with Income-tax Act, 2025 ("the Act") effective from 1st April 2026. The withholding tax rate varies depending on the residential status of the shareholder and the documents submitted by them and accepted by the Company. The Company shall, therefore, be required to deduct tax at source at the time of making the payment of the dividend, if approved by the shareholders at the forthcoming AGM. The applicable TDS rate will depend on various factors, including the shareholder's residential status, availability of a valid PAN, eligibility to claim benefits under an applicable tax treaty (for non-resident shareholders), entitlement to any exemption, and submission of the requisite declarations, documents and information to the Company.
